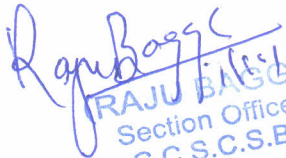

Rules and Regulations:

- i) Inter Ministry Cricket tournament 2014-15 will be played on 20-20 over pattern on **LEAGUE CUM KNOCK OUT basis.**
- ii) Two teams from each group will qualify for Pre-Qtr.finals
- iii) Minimum of 10 overs will constitute a match.
- iv) Simple Average will be considered for deciding a reduced over match due to light and weather conditions.
- v) Points will be awarded as i) Win - 4, ii) Wash out/Tie -2 points each iii) Loss- 0
- vi) In case of wash out in league phase both the teams will be granted 2 points each.
- vii) In case of wash out in knock out phase matches will be replayed.
- viii) Teams must report to the Umpires at the ground 15 minutes before the scheduled start of the match.
- ix) Throughout minimum of 4 players will remain inside the 30 yard circle while fielding.
- x) Walk over will be awarded against the team (minimum of 8 players) which fails to report on the ground maximum of 30 minutes after the scheduled start of the play.
- xi) Decisions of the Umpires are final and binding.
- xii) No request for rescheduling/postponement of matches will be entertained.
