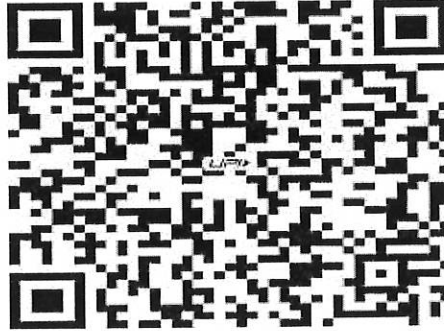
CIRCULAR
